Subject: AB 109 Compliance Sweep in the City of Menifee and surrounding areas.

On March 9, 2022, Operation Four Leaf Clover, a large-scale joint operation between the Central P.A.C.T. (*Post-release Accountability & Compliance Team*) and the Menifee Police Department conducted an operation that focused on compliance checks and warrant services on those individuals on Parole, Probation, Mandatory Supervision, and Post Release Community Supervision (**P.R.C.S.**). The locations were in the City of Menifee and surrounding areas.

Approximately 160 law enforcement personnel from the Menifee PD, Central P.A.C.T, East P.A.C.T, Perris Special Enforcement Team, R.A.S.P. Team, Hemet PD R.O.C.S. Team, San Jacinto Special Enforcement Team, Murrieta PD Special Enforcement Team and Community Policing Team, Riverside County Probation, Gang Impact Team, CRTF Team, California State Parole, Riverside County Sheriff's Dept.-Cois Byrd Detention Center Team and six Riverside County Gang Task Force Regions (Region 1-Coachella Valley, Region 2-Banning/Beaumont Region 3- Hemet/San Jacinto, Region 4-Murrieta/Temecula, Region 6- Lake Elsinore/Perris and Region 7- Corona/Norco) participated in the operation. The operation resulted in the searches/compliance checks of 157 locations and the arrests of 42 individuals for various crimes. The operation resulted in the recovery of one stolen vehicle, several illegal drugs to include a large amount of Fentanyl, drug paraphernalia, various weapons to include 5 firearms and stolen property. One of the subjects arrested had a 1-million-dollar felony warrant for a possible shooting he was involved in. Menifee PD Detective Bureau responded and took over the investigation.

It was discovered that there were several subjects that failed to provide accurate addresses to the probation department so warrants will be issued for those individuals. Central PACT will attempt to locate and arrest these individuals who have failed to comply with their terms of PRCS and Mandatory Supervision (AB109.)

#### **AB109- Public Safety Realignment**

In 2011, Governor Brown signed Assembly Bill (AB) 109. It was Governor Brown's solution for reducing the number of inmates in the state's 33 prisons to 137.5 percent of design capacity by June 27, 2013, as ordered by the Three-Judge Court and affirmed by the U.S. Supreme Court. Implementation of the 2011 Realignment Legislation began October 1, 2011. Under Realignment, newly-convicted "low-level" offenders without current or prior serious or violent offenses stay in county jail to serve their sentence, which increases the county jail population for each individual county. Those individuals released and were previously supervised by State Parole Agents are now being supervised by county probation officers.

Riverside County public safety agencies formed multi-agency task forces, such as the Central P.A.C. Team, to ensure that those individuals on Mandatory Supervision (also referred to as split sentence) or PRCS (Post Release Community Supervision) are in compliance.

#### **Central P.A.C. Team (Post-release Accountability & Compliance Team)**

Central P.A.C.T. was originally formed in February of 2012 with participating agencies which included Hemet Police Department, Palm Springs Police Department, Desert Hot Springs Police Department, Beaumont Police Department, Cathedral City Police Department, Riverside Co. DA's Office, and Riverside Co. Probation Dept.

In May 2013, East P.A.C.T. was formed with primarily law enforcement agencies in eastern Riverside County. West P.A.C.T. was also formed with law enforcement agencies in western Riverside County.

Currently, the Central P.A.C.T. participating agencies are Hemet Police Department, Beaumont Police Department, Murrieta Police Department, Riverside County Probation Department, Riverside County District Attorney's Office- Bureau of Investigations, Riverside County Sheriff's Department, Banning Police Department, and Menifee Police Department.
